Tiburon firm helps to settle farmworker suit

A lawsuit against the nation's largest artichoke producer over unpaid worker time was settled yesterday with the help of a Tiburon law firm.

Thirty-seven current and former employees of Sea Mist Farms and Sea Breeze Harvesting, both affiliated with Ocean Mist of Castroville, will receive \$181,669 in compensation for time they spent traveling to and from Monterey County fields in company vehicles.

The farmworkers were represented in part by the **Talamantes** and **Villegas** law firm, which specializes in labor cases, in the Monterey County Superior Court lawsuit.

A state Supreme Court decision in 2000 established that time spent by a worker in compulsory travel in an employer's vehicle counts as hours worked. In this case, the workers were bused from a parking lot to the fields but were not paid for travel time.

"Our purpose is to compel farmers and farm operations who require workers to work for their benefit to pay those workers for all the time and energy the workers put into that job," said Virginia **Villegas**, an attorney for the workers.

Art Barrientos, vice president of harvesting for Ocean Mist, said buses were provided as a courtesy for the workers but are no longer used.

Ocean Mist settled the lawsuit to avoid costly litigation, Barrientos said.
